The New York State Department of State (DOS) is required by Federal regulations to provide timely public notice for the activities described below, which are subject to the consistency provisions of the Federal Coastal Zone Management Act of 1972, as amended.

The applicant has certified that the proposed activity complies with and will be conducted in a manner consistent with the approved New York State Coastal Management Program. The applicant's consistency certification and accompanying public information and data are available for inspection at the New York State Department of State offices located at One Commerce Plaza, 99 Washington Avenue, in Albany, New York.

In F-2014-0374, or "Croton River HDD Project", Consolidated Edison (or Con Edison) is proposing to supplement two existing 13 kV submarine cable feeders that lay across the bottom of the Croton River between the Town of Ossining and the Village of Croton-on-Hudson with new 13kV distribution feeders installed in high-density polyethylene (HDPE) conduit. The existing feeders, from the Ossining Substation, supply a significant portion of the load in the Village of Croton. The project will consist of the installation of seven (7), five inch HDPE conduits under the river using horizontal directional drilling (HDD) technology. The purpose of the project is to install redundancy to the electric distribution system. At present, there are no spare cables should there be a failure of the existing lines.

The proposed activities would be undertaken within the Local Waterfront Revitalization Program (LWRP) planning area for the Village of Croton-on-Hudson. Activities under federal permitting authority within this planning area are subject to review for their consistency with the local program and its policies. In memorandum, dated July 03, 2014, the Waterfront Advisory Committee (WAC) of the Village of Croton-on-Hudson indicated its recommendation that the proposed activities are consistent with the local program. The Town of Ossining does not have an approved LWRP and activities are not located within the approved LWRP boundary of the Village of Ossining.

The northern landside of the project area encompasses the vanCort-

landt Manor Park and is expected to temporarily interrupt public access to the waterfront section of the park during construction and staging activities (likely to be scheduled for mid-November through mid-March of 2015). According to information provided to the Department of State, physical access to the site by construction crews and equipment, and further coordination of project details as they may impact the site or its normal use, is being undertaken in conjunction with the Historic Hudson Valley District. Construction would begin subsequent to the vanCortlandt Manor's annual Great Jack o'Lantern Blaze and the proposed activities will not affect nor impede the Historic Hudson Valley's ongoing educational and recreational programs and tours held at the park and historic site.

Any interested parties and/or agencies desiring to express their views concerning any of the above proposed activities may do so by filing their comments, in writing, no later than 4:30 p.m., 15 days from the date of publication of this notice or November 6, 2014.
