The Department of Health proposes to amend Sections 86-1.62 and 86-1.63 of the Title XIX (Medicaid) State Plan for Inpatient Hospital Services.

Effective January 1, 1988, New York State established a case based payment reimbursement system for hospital services. Rates under this system are calculated on a per discharge basis rather than a per diem basis. Case based payments are made at a pre-determined specific rate for each discharge.

The case based payment system uses the diagnosis related group (DRG) patient classification system to described the types of patients a hospital treats. The DRG system classifies patients into groups based on the patient's age, condition, diagnosis and procedures performed. The DRG payment system is also sensitive to the medical condition that contributed to the admission of the patient to the hospital and, for neonatal cases, the birth weight.

In order to calculate payments, first the information from the patient's medical record is used to assign the patients to an appropriate DRG. The service intensity weight (SIW), which is a proxy that reflects the amount of resources consumed, is then used to calculate the DRG rate of payment. If the case is an outlier, the trimpoints and arithmetic mean length of stay (LOS) must be used to calculate the appropriate outlier payments.

The State's case based payment system is based on the DRGs used by the Federal prospective payment system (PPS), modified for neonatal and AIDS cases, as required by Section 2807-c(3) of the Public Health Law. Such provision states, "The Commissioner shall establish as a basis for case classification for case based rates of payment the same system of diagnosis-related groups for classification of hospital discharges as established for purposes of reimbursement of inpatient hospital services pursuant to title XVIII of the Federal Social Security Act (Medicare) in effect on the first day of July in the year preceding the rate period." Due to changes in the Federal DRG classification system and a better ability to differentiate among levels of illness or patients within DRGs, modification of the State's DRG system is proposed. These modifications will be effective January 1, 2004 and will enable providers to assign patients to DRG categories more appropriately and, thus, receive more appropriate reimbursement.

The addition, deletion and expansion of DRGs impact the alignment of cases among the DRGs. This alignment of cases affects the determination of the service intensity weights (SIWs) and trimpoints. Thus, the values of the SIWs and trimpoints change. The new values are provided in the proposed amendments to Sections 86-1.62 and 86-1.63 of Title 10 (Health) NYCRR. The proposed amendments also revise the regional group average arithmetic inlier mean LOS that is used to calculate the outlier payment for each DRG.

There is no anticipated increase or decrease in the annual aggregate Medicaid expenditures for 2004 resulting from these amendments. These proposed regulatory changes are intended to modify the DRG classification system by adding and deleting DRGs to enable patients to be more appropriately placed in a DRG category for reimbursement purposes. The realignment of cases among the DRGs will impact the SIWs such that those cases that are more intensive will increase the SIW value, but the removal of such cases from the DRGs to which those cases were previously assigned will decrease the SIW value for these DRGs. Therefore, cost neutrality is anticipated.
