Strategic Planning Technical Assistance Grants

The Governor's Office for Small Cities (GOSC) of the New York State Housing Trust Fund Corporation (HTFC) announces the availability of approximately \$400,000 in Strategic Planning Technical Assistance Grants under the New York State administered Community Development Block Grant (CDBG) Small Cities Program. CDBG

Strategic Planning Technical Assistance Grants provide eligible communities and counties in New York State with an opportunity to obtain technical assistance in order to prepare a community development strategic plan. Eligible non-entitlement communities in New York State are invited to submit an application for a Strategic Planning Technical Assistance Grant.

Communities may apply for up to \$25,000 for assistance to develop a strategic plan that will provide a "vision" for the community and identify implementation steps to achieve specific community development goals and objectives. Eligible communities seeking to develop a strategic plan that will address specific goals and objectives in a downtown/main street area or other similarly defined areas such as central business areas are encouraged to apply. Applications are due to GOSC by October 18, 2004. If mailed, applications must be postmarked no later than October 18, 2004. If hand-delivered, it must arrive no later than 4:00 P.M. on October 18, 2004.

Applications will receive a funding determination based upon the criteria described in the application kit. Preventive Health Grant

The purpose of the New York City Preventive Health Program is to provide direct services resulting in increased access to quality health care and follow-up care with refugees starting and completing immunizations and preventive therapy treatments.

The target populations for the Preventive Health Grant are refugees, asylees, entrants, certified victims of trafficking and other eligible populations that may be designated by the federal Office of Refugee Resettlement.

OTDA anticipates awarding one contract. Applications will be accepted through September 9, 2004 for the Preventive Health Grant totaling \$287,900.00 for a two-year period. For the budget period from 10/01/04-09/30/05, it is anticipated that up to \$143,950.00 will be available.

Eligible applicants must have experience and knowledge of health care needs of the targeted population and of the health care services available throughout New York City to assist the population with identified needs.

Eligible applicants must demonstrate knowledge of the specific cultural and linguistic needs of the target population in accessing or following up with health care services.
