In F-2003-0434, Boatyard Condominium of 210 Carroll Street, City Island, Bronx, NY, 10464, is seeking authorization to repair an existing platform, and install floats and pilings. The applicant proposes to install an 8'2" wide by 250' long floating concrete wave attenuator/walkway on the south side of an existing ramp. A second wave attenuator/walkway would be attached to the waterward terminus of the existing ramp, that would measure 9'10" wide by 300' long. Seven 3'3" wide by 29.5' long finger floats and 83 pilings would be installed to the west of this attenuator. Also proposed is a 6' wide by 180' long floating pier with 12 wedge shaped finger floats, each 4' wide at base, 2' at terminus, and 26' long, with 78 pilings. Approximately 39 boat slips would be created. The stated purpose is to provide mooring slips for residents of a condominium. The proposed project would be located in Long Island Sound, at 210 Carroll Street, City Island, Bronx.
