Clean Water State Revolving Fund (CWSRF) for Water Pollution Control Proposed Supplemental Financing Program

The New York State Environmental Facilities Corporation (EFC) and the Department of Environmental Conservation (DEC) announce the proposed Supplemental Financing Program as part of draft Amendment No. 1 to the Federal Fiscal Year (FFY) 2005 Intended Use Plan (IUP) for the Clean Water State Revolving Fund (CWSRF). The proposed program may provide supplemental funds for the CWSRF which would allow long-term financing of projects in Categories A and B of the final Annual Project Priority List issued in September 2004 that have an existing CWSRF short-term loan. These projects are anticipated to need long-term financing by the end of the IUP financing period (September 30, 2005). The Supplemental Financing Program will accelerate the availability of CWSRF program equity and avoid the disruption of the planned projects in Categories A and B ready for conversion to long-term financing. The funding that may be available through this program will not result in funding of any new applicants or any applicants on the current IUP priority list not having a CWSRF short-term loan.

"Living Well with a Disability" Program

Applications will be accepted through January 24, 2005 for organizations to conduct the "Living Well with a Disability" curriculum.

"Living Well with a Disability" is an eight-week peer led workshop series, developed by the University of Montana and the University of Kansas. The workshops target the prevention and management of secondary conditions among adults with physical disabilities. Preliminary evaluation of the workshop series indicates that individuals who participated in the workshop experienced a decrease in disability due to secondary conditions six months after the end of the workshop. Additionally, these same people reported a 45% decrease in physician visits during this same time period.

The workshop is based on a self-help, health promotion model. It includes eight two-hour sessions that focus on topics including goal setting, problem solving, adopting a hopeful and optimistic attitude, and overcoming depression. In addition, a number of behavioral repertoires are taught, including communication skills, medical information seeking skills, changing one's nutritional intake and level of physical activity, and an introduction to advocacy skills. Organizations interested in conducting the workshop must dedicate two staff to participate in an internet-based train-the-trainer module in order to conduct the workshop; recruit participants for the workshops and conduct data collection before and after completion of the workshop. Maximum funds available is \$4,800.00 for up to eight projects. More information "Living Well with a Disability" program can be found at www.livingwellweb.com.

Case Management and Peer Services in Specific Impacted New York City Adult Homes

In the spring of 2002, at the direction of Governor Pataki, the Commissioner of the Department of Health (DOH) appointed a workgroup to make recommendations to improve conditions for residents in adult care facilities. In response to these recommendations the Office of Mental Health, working in cooperation with the Department of Health and Commission on Quality Care for the Mentally Disabled (CQC), intends to restructure the delivery of mental health services to the mentally ill residents who reside in adult homes that have either 25 residents or 25% of the total resident population receiving mental health services. As part of this initiative the OMH is issuing this Request for Proposals (RFP) for the development of supportive case management (utilizing supportive case managers) and peer services. Case management and peer services will be provided for approximately one thousand fifty (1,050) individuals residing in these adult homes in New York City (Bronx, Kings, New York, Queens, and Richmond Counties).
