Sealed proposals in duplicate for **Prime Contract Nos. 2004-02 through 2004-07** - Village Hall renovations at 85 Main Street, Irvington, New York will be received by the Village Clerk-Treasurer, Irvington, New York, until 11 a.m., April 14, 2004. Immediately thereafter, the bids will be publicly opened and read aloud in the Village of Irvington Village Hall.

The work consists of six individual contract packages. Each bidder is to submit a single bid with prices and costs of the contract packages of their choice. The bidder must be fully qualified to perform the work and provide the labor for each contract price upon which a bid is submitted. Each contract package will be evaluated and awarded separately.

Contract packages are: 2004-02 General Construction Labor, 2004-03 Painting and Finishing, 2004-04 Flooring, 2004-05 Ceramic Tile, 2004-06 Plumbing, and 2004-07 Electrical.

Plans, specifications and standard proposals may be obtained free of charge at the above address during workdays between the hours of 9:00 a.m. and 3:00 p.m. starting March 15, 2004.

There will be a Pre-Bid meeting at the subject property at 10 a.m. on April 6, 2004. Interested Bidders are encouraged to attend.

Bids must be submitted in a sealed envelope and distinctly marked with the name of the bidder and the date and time of the bid. Bids may be delivered or mailed to the Village Clerk-Treasurer on or before the bid opening time and date specified. The Village of Irvington reserves the right to waive any informalities in the bids, or to reject any or all bids. No bidder may withdraw his bid within forty-five (45) days after the actual date of the opening thereof. The prices quoted are to remain in effect until 1 year from the date of acceptance.
