**In F-2004-0659, American Sugar Refining Company, located at 1 Federal Street in Yonkers, NY, 10278,** is proposing the installation of a sub-aqueous (submerged) Soft Dike project near the American Sugar Dock Zone in the Hudson River. The Soft Dike project would direct and/or realign natural river currents to the Dock Zone to prevent sediment deposition and provide a sustainable solution for maintaining operational water depths to reduce or eliminate the need for annual dredging operations. The submerged dike structure would have an average base dimension of approximately 90 linear feet in width by 270 linear feet long, with a crest height set at approximately 10 feet below mean low water. The dike structure would be constructed of sand filled geotextile bags. The stated purpose of the project is to provide a sustainable solution for maintaining operational water depths which will reduce or eliminate the need to annually dredge the project area. The proposed project is located in the Hudson River, City of Yonkers, Westchester County.
