NOW, THEREFORE, be it known that amendments to section 6020.3(a) of Title 9 of the New York State Official Compilation of Codes, Rules and Regulations are hereby adopted and promulgated and shall be effective upon publication in the *State Register*.

1. Subdivision (a) of section 6020.3 of 9 NYCRR is amended to read as follows:

Section 6020.3 Minimum standards. (a) No basic course shall be approved by the commissioner that does not follow a curriculum of at least [510] 475 hours and a supervised field training and orientation program of at least 160 hours.

Pursuant to 42 CFR §447.205, the Department of Health hereby gives public notice of the following:

The Department of Health intends to amend the Title XIX (Medicaid) State Plan for long-term care services to comply with recently enacted statutory provisions. The following significant changes have been included in such provisions:

- Effective on and after January 1, 2007, the operating cost component of payment rates for inpatient services provided by residential health care facilities will reflect the operating component of rates effective October 1, 2006, adjusted for inflation. For the 2008 rate period, the rates will reflect the operating component of rates effective December 31, 2006, adjusted for inflation.
- Rates for the 2007 and 2008 rate periods will be further adjusted by a per diem add-on reflecting the proportional amount of each facility's projected Medicaid benefit to the total projected Medicaid benefit for all facilities of the newly enacted methodology which adjusts the operating component of the rates to costs reported in the 2002 cost report. The adjustment will incorporate elimination of the productivity and efficiency limit (P&E) and the administrative and fiscal cap (A&F) effective as of January 1, 2007. For facilities that do not receive a benefit from the 2002 cost base, the rates will be adjusted to include a proportional add-on resulting from the elimination of the P&E and A&F caps. The aggregate total of these rate adjustments for all facilities will not exceed \$137.5 million for the 2007 rate period, and \$167.5 million for the 2008 period.
- Any rate revisions to the 2006 rates which occur on or after January 1, 2007 will be annually incorporated, retroactively and prospectively, into the 2007 and 2008 rates on or about November 30 of 2007 and 2008, respectively.
- Rates for 2007 and 2008 will fully reflect the cost of local property taxes, and payments in lieu of local property taxes, as reported in each facility's cost report submitted for the year two years prior to the rate year.
- Rates for 2007 and 2008 rate periods will not be subject to a case mix adjustment. A facility may, however, request an adjustment to reflect an increased case mix equal to or greater than .05 if such facility submits supporting data based on a full house schedule of patient review instruments, and continues to make such full house submissions in accordance with its existing submission schedule for rate periods through December 31, 2008.
- For the periods on and after January 1, 2007, voluntary facilities will not be required to deposit reimbursement received for depreciation expenses into a segregated depreciation fund.
- Effective on and after January 1, 2009, the operating cost component of the payment rates for inpatient services provided by residential health care facilities will reflect allowable operating costs as reported in each facility's 2002 calendar year cost report, adjusted for inflation. For facilities that do not receive a benefit from the adjustment to the 2002 cost base, the operating component of the rates for 2009 will not be less than the operating component for the 2008 rate period, including the proportional add-on from the elimination of the P&E and A&F caps.
- For facilities whose operating cost component reflects base year costs subsequent to 2002, the rates will remain on such base.
- The operating component of the 2009 rates will be subject to a case mix adjustment through application of the relative resource utilization groups system (RUGS-III) used by the federal government for Medicare, and revised by state regulation to reflect NYS wage and fringe benefits. The RUGS-III weights will be increased for the following resident categories:
 - * 30 minutes for impaired cognition A;
 - * 40 minutes for impaired cognition B; and
 - * 25 minutes for reduced physical functions B.
 Case mix adjustments will be made in January and July of each calendar year. The adjustments and related patient classifications for each facility will be subject to audit review in accordance with regulations promulgated by the Commissioner of Health.
- The current rate adjustments reflecting the extended care for persons with traumatic brain injury and for the cost of providing Hepatitis B vaccinations will continue on and after January 1, 2009.
- The operating component of the rates effective January 1, 2009 will fully reflect the cost of local property taxes, and payments in lieu of local property taxes, as reported in each facility's cost report for the period two years prior to the rate year. The direct operating component will include allowable therapy costs, as well as the associated overhead. Pharmacy services, non-prescription drugs and supplies, as well as the associated administrative overhead will be reflected in facility rates as non-comparable costs.
- For purposes of computing the cost ceilings for both the direct and indirect operating component of the rates on and after January 1, 2009, facilities will be organized into the following peer groups:
 - * freestanding with less than 300 certified beds;
 - * freestanding with 300 or more certified beds; and
 - * hospital-based facilities.
 For each peer group, a corridor will be developed around the statewide mean direct and indirect price per day, provided, however, that the applicable corridor will have a base no less than 85% and no greater than 90% of each mean direct and indirect price per day. Additionally, the corridor will reflect a ceiling no greater than 115% and no less than 110% of each applicable mean price per day. The total financial impact of applying the ceiling must be substantially equal to the total financial impact of applying the base.
- The operating component of the rates will reflect a per diem add-on of \$8, trended from 2006 to 2009 and thereafter, for each patient who:
 - * qualifies under both RUG-III impaired cognition and behavioral problems categories; or
 - * has been diagnosed with Alzheimer's disease or dementia and is classified in reduced physical functions A, B or C, or in behavioral problems A or B categories, and also has an activities of daily living index of ten or less.

- Additionally, the operating component will reflect a per diem add-on of \$17, trended from 2006 to 2009 and thereafter, for each patient whose body mass index is greater than thirty-five.
- Public facilities, and non-public facilities with fewer than 80 certified beds, which have a facility specific direct and/or indirect adjusted price per day that is equal to the applicable ceiling will have such price per day adjusted by an addition of 50% of the difference between the facility specific price and the ceiling price. The adjustment to the direct and/or indirect price per day will be increased to the rate year by the applicable inflation factor, and adjusted by the regional direct or indirect input price factor.
- Effective for the period January 1, 2007 through December 31, 2011, appointment of a receiver, establishment of a new operator, or replacement or renovation of an existing facility that occurs on or after January 1, 2007 will not result in a revised operating component of the rates unless an application for these changes is filed with the Department of Health by December 31, 2006, that is subsequently approved and which otherwise meets existing Department criteria for the establishment of a new base year for rate-setting purposes.
- For rate periods on and after January 1, 2007, no less than 65% of the additional Medicaid reimbursement received by a facility from the proportional add-on related to the projected 2002 base benefit, the elimination of the P&E and A&F caps, or from the utilization of the 2002 reported base year costs, must be used for recruitment and retention of non-supervisory or other direct resident care workers or for purposes authorized under the Quality Improvement Demonstration Program. However, facilities will not be required to spend more than 75% of the Medicaid reimbursement for these purposes. The Commissioner of Health is authorized to perform audits of the facilities to ensure compliance with this requirement, and may recoup any amount determined to be used for other purposes. The Commissioner may waive the requirements for this mandatory use of this Medicaid reimbursement on request of a facility, if it is determined that the funds are not available for these purposes because they have been used to correct deficiencies at a facility that constitute a threat to resident safety.
- Cost reports submitted by facilities for the 2002 calendar year or any subsequent year used to determine the operating component of the 2009 rate will be subject to audit through December 31, 2014. Facilities will therefore retain all fiscal and statistical records relevant to such cost reports. Any audit of the 2002 cost report, which is commenced on or before December 31, 2014, may be completed subsequent to that date and used for adjusting the Medicaid rates that are based on such costs.
- For the rate periods after 2009, the following categories of facilities will receive rates that are no less than the rates that were in effect for such facilities on December 31, 2006, trended to the applicable rate year:
 - * AIDS facilities or discrete AIDS units;
 - * discrete units for residents on long term inpatient rehabilitation for traumatic brain injury;
 - * long term ventilator discrete units;
 - * discrete units providing specialized programs for residents requiring behavioral interventions; and
 - * facilities or discrete units that provide extensive nursing, medical, psychological and counseling services for children.
- Effective by no later than the 2012 rate period, the operating component of the rates will be based on allowable costs from an annual cost report period which is not earlier than three years prior to the initial rate year, trended to the applicable rate year.

Thereafter, the operating component base year will be updated to be current no less frequently than every six years, provided, however, that current shall mean that the operating components of the initial rate year shall utilize updated base year costs for periods no earlier than three years prior to the initial rate year and trended to the rate year.

The estimated annual increase in gross Medicaid expenditures attributable to these provisions for calendar year 2007 is \$137.5 million and for calendar year 2008 \$167.5 million.
