Division of Housing and Community Renewal (HCR)
(Re: HCR-15-09-00003-P)

Purpose:

The New York State Division of Housing and Community Renewal ("DHCR") will hold two (2) public hearings to receive comments regarding DHCR's proposed amendment of its regulations concerning "State-Assisted Housing Constructed by Private Enterprise" at 9 NYCCR Parts 1700 - 1760 ("the Proposed Regulations"). The Proposed Regulations govern both limited-profit and limited-dividend housing companies organized under Article II and Article IV of the Private Housing Finance Law. Notice and a summary of the Proposed Regulations (D.O.S. Id. No.: HCR-15-09-00003-P) were published in the April 15th edition of the *State Register*.
