Department of Health

Pursuant to 42 CFR Section 447.205, the Department of Health hereby gives public notice of the following:

The Department of Health proposes to amend the Title XIX (Medicaid) State Plan for institutional services to comply with proposed regulatory changes. The following significant changes are proposed:

Institutional Services

- The Commissioner may grant approval of a temporary adjustment to general hospital inpatient rates, as calculated pursuant to a proposed amended 10 NYCRR 86-1.31(b), for hospitals subject to mergers, acquisitions or consolidations that took place prior to the base year the hospital's current inpatient Medicaid rate is based on, provided such hospitals demonstrate through submission of a written proposal that the merger, acquisition or consolidation will result in an improvement to (i) cost effectiveness of service delivery, (ii) quality of care, and (iii) other factors deemed appropriate by the Commissioner. Such written proposal shall be submitted to the Department 60 days prior to the requested effective date of the temporary rate adjustment. The temporary rate adjustment shall consist of the various operating rate components of that portion of the hospital originally associated with the surviving hospital provider number and shall be in effect for a specified period of time as approved by the Commissioner. At the end of the specified timeframe, the hospital will be reimbursed in accordance with the statewide methodology set forth in regulation. The Commissioner may establish, as a condition of receiving such a temporary rate adjustment, benchmarks and goals to be achieved as a result of the ongoing consolidation efforts and may also require that the hospital submit such periodic reports concerning the achievement of such benchmarks and goals as the Commissioner deems necessary. Failure to achieve satisfactory progress, as determined by the Commissioner, in accomplishing such benchmarks and goals shall be a basis for ending the hospital's temporary rate adjustment prior to the end of the specified timeframe.

The estimated annual net aggregate increase in gross Medicaid expenditures attributable to this proposed initiative for state fiscal year 2010/2011 is \$2.6 million.
