Pursuant to the provisions of section 1111(j)(2) of the Tax Law, the Commissioner of Taxation and Finance is required to give public notice of the base retail price adjustment calculation and the resulting base retail price of cigarettes for purposes of establishing the prepaid sales tax on cigarettes imposed by section 1103 of the Tax Law. Section 1111(j) of the Tax Law was amended by Chapter 85 of the Laws of 2002 to provide that the base retail price of cigarettes shall be adjusted each year by a factor based upon the manufacturers' list price for a carton of standard brand cigarettes. The base retail price adjustment factor for the period September 1, 2012, through August 31, 2013, is 1.042. The base retail price adjustment calculation results in a base retail price of cigarettes effective September 1, 2012, as follows:

Package of twenty (20) cigarettes: \$9.575 x 1.042 = \$9.977
For each additional five (5)
cigarettes: \$2.392 x 1.042 = \$2.492
