The applicant has certified that the proposed activity complies with and will be conducted in a manner consistent with the approved New York State Coastal Management Program. The applicant's consistency certification and accompanying public information and data are available for inspection at the New York State Department of State offices located at One Commerce Plaza, 99 Washington Avenue, in Albany, New York.

In F-2012-0691, Noank Village Boat Yard, 38 Bayside Avenue, Noank, Town of Groton, CT, is proposing to modify their previously authorized maintenance dredging of approximately 5,000cy with an additional 4,000cy over overdredge from the existing commercial marina. The original proposal was for mechanical dredging with un-confined placement of the material at the Central Long Island Sound Disposal Site (CLIS). The applicant now seeks to place the dredged material at the New London Disposal Site (NLDS). The U.S. Army Corps of Engineers, New England District (Corps) with concurrence from the U.S. Environmental Protection Agency (EPA), had determined that the dredged material is suitable for un-confined open-water placement at the CLIS. The material was also found to not be suitable for un-confined open-water placement at the NLDS and would be required to be capped with suitable material. The CLIS is an EPA designated open-water disposal site located within Long Island Sound, approximately 5.6 nautical miles south of East Haven, CT. The NLDS is located 3.1 nautical miles south of Eastern Point in Groton, CT and within approximately 2.0 nautical miles from Race Point in Fishers Island, NY.

The applicant is seeking authorization for this activity under the U.S. Army Corps of Engineers' Connecticut Programmatic General Permit, previously reviewed and concurred with by the Department of State [see F-2011-0086 (DA)].
