

Time and Date:

A public hearing will be held on Friday, September 2, 1988, commencing at 10:00 a.m.

Place:

Auditorium of The Brooklyn Union Gas Company, 195 Montague Street, Brooklyn, New York.

Purpose:

New York State Energy Research and Development Authority ("Energy Authority") has the power, pursuant to Title 9 of Article 8 of the New York State Public Authorities Law, to issue tax-exempt and taxable non-recourse revenue bonds and notes to finance special energy projects, including facilities for the local furnishing of gas. The Brooklyn Union Gas Company ("Brooklyn Union") has requested the Energy Authority to issue obligations, in one or more series, within three years from the date of the hearing referred to below, pursuant to a plan of financing, in a maximum aggregate principal amount at any one time outstanding not to exceed \$145 million ("Bonds"), for the purpose of financing a portion of the costs of acquiring, constructing and installing certain facilities for the local furnishing of gas ("Project"). The Members of the Energy Authority are expected to consider and act upon such request at future meetings of the Energy Authority.

The Project consists of certain facilities owned and operated by Brooklyn Union for the furnishing of gas within Brooklyn Union's service area in the City of New York and certain related facilities. The Project facilities include gas distribution mains, gas meters, house regulators, district gas regulators, transportation and power operated equipment, other general operating equipment of an administrative nature, additions and improvements to certain distribution pipes ("services"), various facilities for measuring gas and regulating pressure, additions and improvements to property used in liquifying, storing and regasifying liquified natural gas and in manufacturing substitute natural gas, facilities used in the extraction of methane from landfill sites, and other associated facilities. The Project facilities are located in a widespread geographical area in the Boroughs of Brooklyn, Staten Island and part of Queens, all within the City of New York. The executive offices of Brooklyn Union are located at 195 Montague Street, Brooklyn, New York.

The purpose of the hearing is to receive the views of interested members of the public concerning issuance of the bonds. Interested persons are invited to submit written comments, speak at the public hearing, or both. Written comments must be received by the Energy Authority no later than Thursday, September 1, 1988 by mail or hand delivery to Jacquelyn L. Jerry at the address below, unless submitted by hand delivery to the presiding official at the public hearing. STATEWIDE—Pursuant to 15 CFR 923.84(b), the New York State Department of State (DOS) hereby gives notice that the Federal Office of Ocean and Coastal Resource Management (OCRM) concurred on July 1, 1988 for the Town of Esopus Local Waterfront Revitalization Program, and on July 14, 1988 for the Village of Cape Vincent Local Waterfront Revitalization Program with DOS on two routine program implementation actions. The actions are the incorporation of the Town of Esopus and the Village of Cape Vincent Local Waterfront Revitalization Programs into New York State's Coastal Management Program (CMP). DOS requested OCRM's concurrence on July 16, 1986 for the Town of Esopus Local Waterfront Revitalization Program and on October 15, 1986 for the Village of Cape Vincent Local Waterfront Revitalization Program in previous notices in the *State Register* which further described the content of the implementation action.

Pursuant to the State CMP and Article 42 of the NYS Executive Law the NYS Secretary of State approved the Town of Esopus LWRP on November 17, 1987 and the Village of Cape Vincent LWRP on June 9, 1988.

As of the date of this notice, Federal consistency applies to the Town of Esopus and Village of Cape Vincent LWRP's.
