Routine Program Implementation Notice

STATEWIDE — Pursuant to 15 CFR 923.84 (b), the New York State Department of State (DOS) hereby gives notice that the federal Office of Ocean and Coastal Resource Management (OCRM) concurred on March 5, 1996 on the incorporation of amendments to the ~~Mamaroneck and Village of Larchmont~~ Local Waterfront Revitalization Program (LWRP) into the State's Coastal Management Program (CMP) as a routine program implementation action. DOS requested OCRM's concurrence on this action on January 17, 1996 in a previous notice in the *State Register* which further described the content of the action.

Pursuant to the State CMP and Article 42 of the Executive Law, the amendments to the Town of Mamaroneck and Village of Larchmont LWRP were adopted by the Town of Mamaroneck on December 5, 1994, by the Village of Larchmont on December 7, 1994, and approved by the New York State Secretary of State on November 11, 1995. The Town of Mamaroneck and Village of Larchmont LWRP was originally approved by the New York State Secretary of State and incorporated into the State's Coastal Management Program as a routine program implementation action during 1986.

Federal consistency with the Town of Mamaroneck and Village of Larchmont's amended LWRP applies as of the date of this notice.
