Routine Program Implementation Notice**

PURSUANT to 15 CFR 923.84(b), the New York State Department of State (DOS) hereby gives notice that the Federal Office of Ocean and Coastal Resource Management (OCRM) concurred on August 12, 1985 with DOS on two routine program implementation actions. The actions are the incorporation of the Village of Mamaroneck and the Village of Saugerties Local Waterfront Revitalization Programs into New York State's Coastal Management Program (CMP). DOS requested OCRM's concurrence on June 20, 1984 and September 5, 1984 respectively in previous notices in the NYS Register which further describe the content of the implementation action.

The NYS Secretary of State approved the Mamaroneck LWRP on May 21, 1985 and the Saugerties LWRP on October 8, 1985 pursuant to the State CMP and Article 42 of the NYS Executive Law.

As of the date of this notice, federal consistency applies to the Mamaroneck and Saugerties LWRP as incorporated into the State CMP.
