NOTICE OF AVAILABILITY OF AIR ENFORCEMENT GUIDANCE MEMORANDUM

STATEWIDE — The Department of Environmental Conservation has prepared an Enforcement Guidance Memorandum (EGM) extending the limited amnesty period for small businesses established in a November 1, 1994 EGM. This revision has been made necessary by unforeseen delays in the implementation of revisions to the 6 NYCRR Part 201 "Construction and Operating Permits" rule. Part 201 is currently being revised to incorporate the requirements of Title V of the Clean Air Act and to further regulatory reform in the state permitting program.

The revised EGM establishes an Interim Amnesty Period which will be effective immediately and will terminate upon the Department's adoption of the pending revisions to Part 201. Pursuant to the terms of the EGM, qualifying small business may entirely avoid penalties associated with their failure to have a certificate to operate by submitting an application for a permit to construct and operate or by submitting a Letter of Intent (forms are attached to the EGM). This Interim Amnesty policy also provides for qualifying small businesses that would be exempted under the proposed revisions to Part 201 to be treated as if the proposed exemptions are already in effect.

However, during the next six months, the DEC will consider revisions to the EGM if experience and/or comments raise significant issues or area to improve the document.
